Intro to SHAC -

To express the local community values toward health

- New amendment to HB 1525
- Requirements of SHAC
  - Present abstinence curriculum as the preferred behavior before marriage
  - Apply new language regarding sexual activity and contraception
- SHAC recommendations are sent to School District's Governing Board
- New TEKS take effect in the fall of 2022
- Parent notification and consent (opt-in,14-day notification before presenting)
  - Permission must be on a separate form from other permissions collected
- TEKS
  - Knowledge and skills
  - Expectations
  - Six areas of review
    - Physical Health and Hygiene; Mental Health and Wellness; Healthy Eating and Physical Fitness; Injury and Violence Protection and Safety; Alcohol, Tobacco, and Other Drugs; Reproductive and Sexual Health (beginning in 4<sup>th</sup> grade)
  - Be aware of current laws
  - o Included in new TEKS

- Puberty (4<sup>th</sup> grade)
- K-12 healthy relationships
- Refusal skills
- STDs/STIs
- Emotional risks
- Contraception effectiveness
- Violence, sexual abuse, sex trafficking\* (\*already in TEKS)
- Not included in new TEKS
  - Consent Education
  - Gender Identity/Sexual Orientation/LGBTQ
  - If they chose to, each community can add additional topics to their program even if they are not in TEKS
  - Instructional Materials
    - None approved for elementary
- K-12 Standards for Optimal Sexual Development is available for a resource
- 4 curriculums comply with all TEKS slide 70 in presentation
