 - Meet the New You Video: Elle liked video content and that the video was narrated by students. Elle felt some graphics were intense regarding hair growth.

- [Vicky Bayer](#) shared that SHAC may choose to mix videos from different companies for different grades
- The Advocacy Center Puppet program was well received
- Jason Baughman spoke on the different methods of curriculum development
 - The process of Curriculum development is driven by the TEKS requirements
 - The SHAC recommends a curriculum to the Board of Trustees
- Elle gave feedback on the child abuse program by Dr. Jason Sharp

- She felt the message was lost in the format of the video. Elle expressed the content was thorough although she has concerns about generational conflicts and some culture issues
- [Jason Baughman](#) mentioned the content Elle critiqued was outside the purview of SHAC however, will be available for public comment in other venues.
- Cheryl Evans explained 'Super Chick' and other Counseling content.
- [Jason Baughman](#) explained that recommending multiple curriculums may result in campuses presenting different programs.

- A motion was made to recommend High School Health 1 & 2, from Goodheart-Wilcox, by Cheryl Evans and seconded by Amrita Oshan. The motion passed unanimously.
- A motion was made to recommend Goodheart-Wilcox 6th grade curriculum by Cheryl Evans and seconded by Vicky Bayer. The motion passed. Bob Cubbage abstained.
